1. Description of event:

Programs with local and international participants over the period of four weeks. Participation is only possible after registration and invitation.

2. 3 G-rule:

Only people, who are fully vaccinated against Covid 19, can provide proof of recovery from Covid 19 issued by a medical office or health department (not older than 6 months), or can provide a negative rapid antigen test every 24 hours or a negative PCR test every 48 hours are eligible for participation. Participants can get tested (chargeable) on campus. The vaccination status will be checked on the day of arrival or in accordance with test intervals.

The test obligation can be suspended if the 7-day incidence in the district of Munich is stable below a value of 35.

The participants will be informed about the measures in advance.

3. Contact tracing:

The contact details of the participants (surname, first name, address, email address and period of stay) will be requested as part of the registration for the event, processed and stored in agreement with the TUM data protection officer in accordance with Art. 32 DSGVO and Art. 32 BayDSG.

4. General rules regarding hygiene and behaviour inside the building:

The hygiene concept is clearly displayed in the building and participants are instructed in the protective measures before the start of the event. The emergency chain and emergency organization are ensured at all times and there is always a first aider on site during normal office hours.

Participants are requested to wash their hands for at least 20 seconds in the available sanitary facilities (adjacent ground floor and basement, MIAPP building). Liquid soap and disposable towels are available. Hand hygiene infographics are prominently displayed. Attention is drawn to the cough and sneeze etiquette. In addition, disinfectant dispensers filled with Ecolab Skinman Soft for disinfecting hands are available at the entrances to the building and the entrance to the kitchen area.

Contact surfaces and shared work equipment (door handles, surfaces, desks, sanitary rooms, etc.) are cleaned daily and additionally disinfected with Bacillol AF as required.

5. Mask Wearing:

In the building and all premises as well as sanitary facilities, the obligation to wear a surgical mask applies if compliance with the minimum distance of 1.5 m is not possible. Attention is drawn to both with appropriate signs.

The mask can be removed at the individual fixed seat or standing place, as far as the minimum distance between persons from different households can be maintained. If the minimum distances between members of different households cannot be maintained in the multi-space offices, wearing a masks is also required at the desk.

6. Minimum Distance:

In the building, the minimum distance of 1.5 m is observed wherever possible. In areas where this is not possible, a surgical mask must be worn. Routing is designed to avoid physical contact between participants (one-way concept).

In front of the MIAPP check-in offices, the minimum distances are marked on the floor to facilitate the selection of the distance. The same applies at the entrance to the seminar room. More than 10 people are not queuing at any time.

7. Ventilation:

Intermittent ventilation (every 45 minutes for 5-10 minutes) and/or permanent opening of the windows, especially in the seminar room and in the common rooms, ensures regular air exchange. As an additional protective measure, CO2 detectors are installed in the seminar room, all multiple offices and common rooms. An electronic air purifier is also installed at the ceiling of the seminar room.

8. Kitchen and Catering:

China and cutleriy are cleaned in the dishwasher at at least 60 degrees Celcius. Coffee machines and water dispensers are disinfected at short intervals with Bacillol AF.

9. Work space safety

MIAPP employees are housed in individual offices and are provided with surgical masks. Plexiglas partitions are available for installation above the reception counters. Attention is paid at all times to maintaining the minimum distance of 1,5m. A dispenser filled with Bacillol AF is available at the workplace for disinfecting hands and surfaces/materials.

10. Violations of aforementioned rules:

Individuals with Covid 19-associated symptoms (acute, nonspecific general symptoms, loss of smell and taste, respiratory symptoms of any severity) will be excluded from the event. Same applies to individuals who had contact with Covid 19 cases in the past 14 days. Participants will be informed of the exclusion criteria in advance. If any of the exclusion criteria are violated, the TUM Coronavirus Crisis Team will be notified immediately. Participants and staff will be excluded from the event if the hygiene protection concept is not observed. The domiciliary rights will be used consequently.
